**A Bylaw to Amend the City of Charlottetown Election Bylaw**  
**Bylaw # 2018– 08-A**

**BE IT ENACTED** by the Council of the City of Charlottetown as follows:

**PART I – INTERPRETATION AND APPLICATION**

**1. Title**

1.1. This bylaw shall be known and cited as the “Election Bylaw Amendment Bylaw.”

**2. Purpose**

2.1. The purpose of this bylaw is to amend the City of Charlottetown’s election bylaw to correct effective dates.

**3. Authority**

3.1. This bylaw is adopted pursuant to Part 3 and Part 5, Division 2, of the *Municipal Government Act* R.S.P.E.I. 1988, Cap. M-12.1, the Municipal Election Regulations, and the Campaign Contributions and Election Expenses Bylaw Regulations.

**4. Definitions**

4.1. In this bylaw, any word and term that is defined in the *Municipal Government Act*, the Municipal Election Regulations, the Campaign Contributions and Election Expenses Bylaw Regulations, or the City of Charlottetown Election Bylaw has the same meaning as in that Act, regulations or bylaw.

**5. Part V – Campaign Contributions and Election Expense Disclosure – of the City of Charlottetown Election Bylaw is hereby amended by the following:**

5.1. The final paragraph in Section 11. Election Expenses shall be numbered 11.6.

5.2. The following text shall be inserted after subsection 12.4

*12.5 Campaign contributions shall only be received by a candidate during the campaign contribution period as defined in the Campaign Financing Regulations.*

**6. Part III – Administrative – of the City of Charlottetown Election Bylaw is hereby amended by the deletion of the existing section 40 and the substitution of the following:**

40. Effective Date

Part 5 – Campaign Contributions and Election Expense Disclosure, Subsections 11.1 to 11.5, subsections 12.1 to 12.3 and subsection 12.5 shall be effective on January 1, 2019. The remainder of the bylaw shall be effective on the date of approval and adoption.

**Part III – Approval and Adoption**

**7. Effective Date**

7.1. This Election Bylaw Amendment Bylaw, #2018-08-A, shall be effective on the date of approval and adoption below.

**First Reading:**

**Second Reading:**


