6. REPORTS OF COMMITTEES / RESOLUTIONS

6.1 Planning & Heritage - Coun. Greg Rivard, Chair

Councillor Rivard indicated his Committee's report was included in the weekend package.

RESOLVED:

That the request to direct staff to issue a statement of concurrence to Industry Canada in relation to the proposed Antenna System (Eastlink Tower) at 162 Sherwood Road (PID #823120), be approved.

In response to a question raised, Councillor Rivard confirmed that even if Council rejected the application, Industry Canada has the authority to proceed with the installation of an antenna system without the City's approval.

And that this designation of authority shall cease if the job duties of this employee no longer requires the designation, if the employee terminates employment with the City of Charlottetown or upon further written notice.

Councillor Rivard indicated that there was nothing provided to Planning staff that made them feel that Council's decision, in any capacity, was incorrect based on the information.

for Lot 2014-6 Towers Road (PID# 1076728), be approved, subject to design review for the portion of the building with affordable housing and the signing of the amended development agreement.

A question was raised regarding the elimination of underground parking. Councillor Rivard indicated that the developer chose to add 28 affordable housing units as opposed to going with underground parking.

6.2 Water & Sewer Utility - Deputy Mayor Jason Coady, Chair

Deputy Mayor Coady indicated his Committee's report was included in the weekend package.

6.3 Public Works & Urban Beautification – Coun. Mike Duffy, Chair

Councillor Duffy indicated his Committee's report was included in the weekend package. He reported that as a pilot project regarding traffic flow, a 3-way stop will be put in place at Brighton Road and North River Road and the stop signs will be removed from Sandstone Road at Thompson Drive.

It was noted that Beach Grove Road, from Maypoint Road heading towards Beach Grove Home, was not on the list for new sidewalks. It was requested that the department reconsider and add this particular section.

RESOLVED:

That the City enter in to a two (2) year lease extension agreement, with the option of a 1-year extension, with Cape D'Or Holdings Limited for the property at 68 Kensington Rd in the amount of \$37,200.00/year (plus applicable taxes),

And that the Mayor and CAO are hereby authorized to execute any standard contracts/agreements to implement this resolution.

6.5 Environment & Sustainability – Coun. Terry MacLeod, Chair

Councillor MacLeod indicated his Committee's report was included in the weekend package. He reported that the City has launched a campaign entitled "Bring It Charlottetown", to encourage residents to reduce their use of single-use plastics. Individuals can choose from a number of reusable items provided by the City (free of charge), make a pledge to Bring It with them and use it instead of single-use disposable versions of the same items.

RESOLVED:

That the City of Charlottetown withdraw the existing application to the Investing in Canada Infrastructure Program to purchase two mini transit buses at a total project cost of \$237,000 (HST included) and submit an application to purchase two mini transit buses at a total project cost of \$472,500 (HST included) to allow for a superior transit buses that offer greater accessibility for transit riders and that include electronic fare boxes for improving ridership data,

And that the City's contribution to this project be adjusted from \$45,000 (HST included) to \$90,000 (HST included),

And further that the City's contribution is equivalent to 19% of the total project costs with federal, provincial and municipal funding partners covering the remaining costs;

Be it Further Resolved that the City's contribution to this project be changed from the 2019-2020 Capital Budget to the 2020-2021 Capital Budget.

BE IT RESOLVED THAT the partnership agreement clause V (b) – Reporting requirements be amended to read as "Upon completion of the construction of the facility, CARI will provide, on a monthly basis, standard accepted financial statements on the operation of the facility as well as annual audited statements within 120 days of the CARI year end."

6.11 New Business

RESOLVED:

Whereas, there is continuing concern of the existence of individuals conducting illegal activities such as the selling of drugs from their residence; and

Whereas, there is a need to hold these individuals and the property owners accountable so to ensure the health and safety of all residents of the City of Charlottetown are protected, in particular our youth; and

Whereas, Prince Edward Island is one of two Provinces that have not yet enacted civil forfeiture statutes;

Therefore Be it Resolved, that City Council support the creation of a Provincial Civil Forfeiture Law as a means for government to seize criminals' property and fight organized crime;

And Further that the City write Premier Dennis King to ask his Government to create such legislation.

It was strongly recommended that the matter be brought to the Protective and Emergency Services Committee for a thorough discussion.
