

City of Charlottetown
A Bylaw to Amend the Remuneration Bylaw
Bylaw #2020-RMN-01A

BE IT ENACTED by the Council of the City of Charlottetown as follows:

PART I – INTERPRETATION AND APPLICATION

1. Title

- 1.1. This bylaw shall be known and cited as the “Remuneration Bylaw Amendment Bylaw.”

2. Purpose

- 2.1. The purpose of this bylaw is to amend the City of Charlottetown’s Remuneration Bylaw to include the option of a Tax-Free Savings Account under the Benefits & Severance section.

3. Authority

- 3.1. Pursuant to Section Part 5, Section 134 (1) – Revision of Bylaws of the Municipal Government Act R.S.P.E.I. 1988, Cap M-12.1.

4. Definitions

- 4.1. In this bylaw, any word and term that is defined in the *Municipal Government Act*, or the City of Charlottetown Remuneration Bylaw has the same meaning as in that Act or bylaw.

5. SCHEDULE ‘A’ – of the City of Charlottetown Remuneration Bylaw is hereby amended by the following:

5.1. Benefits & Severance

Amend section within Benefits & Severance from:

“Members of Council are eligible for enrollment in the City of Charlottetown’s group Registered Retirement Savings Plan at a contribution rate of 12.25% of regular bi-weekly earnings.”

To:

*“Members of Council are eligible for enrollment in the City of Charlottetown’s group Registered Retirement Savings Plan **(RRSP) or Tax-Free Savings Account (TFSA)** at a contribution rate of 12.25% of regular bi-weekly earnings.”*

PART II - Approval and Adoption

6. Effective Date

6.1. This Remuneration Amendment Bylaw, #2020-RMN-01A, shall be effective on the date of approval and adoption below.
